1. All Rates are net/net prices. VAT charged in accordance with applicable regulations.
2. The Lufthansa Cargo Service Fee for Poland of EUR 14 / MAWB in accordance with TACT Rules added to all terminal charges in export and import.
3. In the case of handling the goods outside the warehouse (wrapping/presentation at the UC) a fee of 50 EUR min or 0.03 eur/kg (the basis is the chargeable weight of the goods) + shipping fee according to the price list will be charged
4. In the event of a shipment is withdrawn, the handling terminal charges are due in accordance with the price list.
5. The maximum lifting capacity of the forklift in the warehouse is 5000 kg. In the case of handling heavier shipments, please send a pre advice.
6. The maximum dimensions of a shipment for security control are 145x180 cm. In the case of larger dimensions, it will be necessary to prepare the goods for manual security control.
